Farm Dog Certification Tests Open to All Breeds

The AKC Farm Dog Certified Test is open to all dogs at least 9 months of age that are individually registered with the AKC, recorded in the FSS program, dogs with PAL numbers, or neutered dogs enrolled in the AKC Canine Partners program. Females in season may not participate.

Ribbons: Test Qualifying Score - Dark Green

****There are no placements for dogs competing in the Farm Dog Certified Test,
only Pass or Fail.**

- A separate entry blank must be completed for each dog entered.
- Bitches in season may not enter.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from the competition by action of the Event Committee.
- Dogs must wear a secure, well-fitting, FLAT collar during the test evaluation and be held on a proper fixed-length leash at all times while on the farm site unless confined in a crate, kennel, or vehicle. The leash shall be four to six feet in length. All dogs must be on leash at all times.
- NO FLEXI-TYPE RETRACTABLE LEASHES ALLOWED ON SITE.
- You are responsible for picking up after your dogs and disposing of waste in the proper receptacles. A failure to do so could result in you and your dog being dismissed from the test grounds and be barred from competing.
- Under no circumstances will dogs be allowed to disturb the resting herding stock nor to interfere outside the testing area with another dog's performance in the test areas. The Judge(s) may request the removal of any dog from the immediate test area at any time, if she determines the presence of the dog presents a risk to livestock, other dogs or persons the farm.
- Un-entered dogs are NOT allowed in the test areas.
- Owners or their Agents are solely responsible for the presence of their dogs at the Test area. Judges are not required to wait for dogs.
- Exhibitors should follow their veterinarians' recommendations to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.
- No entry fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, act of God, public emergency, act of public enemy, extreme weather conditions, or any other cause beyond the control of the Event Committee.
- Children must be accompanied by and kept under the direct supervision of an adult at all times.
- Please bring your own chairs and shade and water for you and your dog.
- Please vacate the premises upon completion of the tests.
- No telephone, fax, online entries or credit card payments will be accepted. Returned checks do not constitute a valid entry fee. The OESCSW will add a \$35.00 collection to the amount of each returned check.
- NO alcoholic beverages are allowed at the farm site.

I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.
